- 6. Bidders who attend without a bid document will not be allowed to the briefing.

- 8. Late submissions will not be accepted.
- 9. Faxed or e-mailed bids are not accepted.
- 10. Only Bidders registered on the Central Supplier Database (CSD), and within the applicable CIDB grading level <u>2GB AND ABOVE</u> will be legible to submit bids/quotations.

- 11. Bidders must submit Certified B-BBEE or EME certificates issue by Verification Agency accredited by SANAS or original sworn affidavit signed by commissioner of oaths (copy of copy not allowed). All B-BBEE certificates that have been issues by verification agencies or professions who are not accredited by South African National Accreditation Systems will be rejected. All material must be SABS Approved.
